On Friday, April 12, The College of Law hosted former South African Constitutional Court Justice Albie Sachs. Justice Sachs delivered his lecture, *The Sacred and the Secular: South Africa's Constitutional Court Rules on Same-Sex Marriages*, holding the audience in rapt attention as he told the story of the process and decision-making that lead the Constitutional Court to rule in favor of same-sex marriages in 2005. The lecture, part of the Roy R. and Virginia F. Ray Lecture Series, was well attended, and was followed by a brief question-and-answer session. Justice Sachs presented to the College of Law a copy of the Constitution of South Africa to commemorate his visit.



# Collin Schueler Announced as Visiting Assitant Professor
