## UK Law Feb. 2011 Bar Passage Results

Once again, our graduates exceeded the state average for first-time and all test takers on the February 2011 Kentucky Bar Examination. This year, 86% of first-time test takers from UK passed, compared with 84% statewide. UK's overall pass rate was 82%, while the state's overall pass rate was 75%.
