UK Law Hosts Kentucky Court of Appeals

The Kentucky Court of Appeals heard oral arguments at the College of Law Courtroom in April. The court session was open to students, allowing them to witness judges Irv Maze, Janet Stumbo and Laurance VanMeter preside over two cases: *Padgett v. Bowlin Group, LLC*, dealing with workers’ compensation benefits, and *Collins v. Commonwealth*, over claims of ineffective assistance of trial counsel.

Prior to the court session, the judges held a lunchtime question and answer session with College of Law students.

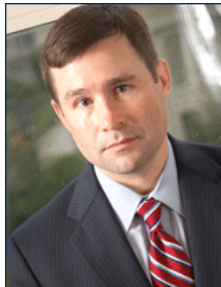
