Law Student Appointed to Governor's Panel

Kentucky Governor Steve Beshear appointed UK Law 3L Christopher J. "CJ" Ryan to the Council for Postsecondary Education. Yale Law's Akhil Amar Speaks at UK Law

Akhil Amar, Sterling Professor of Law and Political Science at Yale University, delivered the Roy and Virginia Ray lecture on October 9, 2012 at the University of Kentucky College of Law. Professor Amar's remarks were based on his new book, America's Unwritten Constitution: The Precedents and Principles We Live By. His lecture summarized the twelve different contexts for constitutional interpretation that he discusses at length in his book. The lecture was preceded by an hour-long question-and-answer session with law students and followed by a book signing and reception and dinner with local state and federal judges. Faculty Notes

Jennifer Bird-Pollan was one of 20 pre-tenure tax professors invited to participate in the 7th Annual Junior Tax Conference at the University of California Hastings this summer. She presented on Moral Philosophy and Redistributive Tax Policy, and also commented on two papers. She has been invited to present a paper and to comment on a paper at the Victoria-Cornell Colloquium on Jurisprudential Perspectives of Taxation Law, which will occur in September at the Cornell Law School. In November, she will present a paper at the Harvard Law School Tax Policy Seminar.

In September, **Joshua A. Douglas** delivered the Constitution Day Lecture, "Resolving Disputed Elections," at Xavier University and presented "Election Law Pleading" at the Inaugural Election Law Junior Faculty Workshop at Loyola Law School. On Wednesday, September 12, the UK College of Law hosted "Lawyering in the Public Interest," the third annual James and Mary Lassiter Distinguished Visiting Professor Conference. **Beverly I. Moran,** the 2012 Lassiter Distinguished Visiting Professor, led a group of prominent speakers through the day's events, which included a breakfast address from Wm. T. (Bill) Robinson III (1971), immediate past president of the American Bar Association on the importance of public interest work. Panels throughout the day featured notable professors and practitioners, including Pete Isajiw of Cadwalader Law Firm, Blanche B. Cook, Assistant U.S. Attorney, and LaToi D. Mayo (2001) an attorney at Littler Mendelson in Lexington.

The day concluded with a showing of the film *The Invisible War*, introduced by Susan L. Burke, an attorney who transitioned from large-firm practice to advocate for whistle-blowers, American servicewomen, and Iraqi families injured by the Blackwater corporation.
