College of Law Events

- Dean Brennen increased diversity efforts by restructuring staff positions at the College of Law to have a designated diversity officer position. The diversity duties were assumed by Danny Murphy whose title changed from Assistant Dean of Administration and Community Engagement to Assistant Dean of Community Engagement and Diversity.
- College of Law Diversity Committee and law faculty hosted book group discussions of *Flagrant Conduct* with incoming first-year law students. The initiative began the weekend of orientation for incoming law students.
- College of Law Diversity Committee hosted an ice cream social with a focus on student members of the Black Law Students Association, Latino Law Students Association, Muslim Law Students Association, Women's Law Caucus and OUTLaw.
- College of Law Diversity Committee hosted a discussion forum on the topic "Zimmerman's Gun."
- College of Law Admissions hosted undergraduate students, faculty and staff from Kentucky State University as part of a pipeline initiative to increase diversity in law school.
