FALL 2025

- **August 25 - Monday - Class work begins**
- August 25 – Monday - Last day a student may officially drop a course or cancel registration with the University Registrar for a full refund of fees
- August 29 – Friday – Last day to add a class for the 2025 fall semester
- September 1 - Monday - Labor Day - Academic Holiday
- September 5 – Friday – Last day to fully withdraw or reduce course load and receive an 80% refund
- September 12 - Friday - Last day to change grading option (credit to audit or audit to credit)

- September 12 - Friday - Last day to officially withdraw from the University or reduce course schedule and receive a 50 percent refund

- December 5 - Friday - End of classwork
- December 6-8 - Saturday through Monday - Law Examination Reading Period

- January 19 - Monday - Martin Luther King Day - Academic Holiday
- January 23 - Friday - Last day to officially withdraw from the University or reduce course load and receive an 80 percent refund.
- January 30 - Friday - Last day to drop a course without it appearing on student's transcript
- January 30 – Friday - Last day to change grading option (credit to audit or audit to credit)
- January 30 - Friday - Last day to officially withdraw from the University or reduce course schedule and receive a 50 percent refund
- February 11 – Wednesday - Deadline to appeal Kentucky residency status determination for the 2026 spring semester
